APPLICATION

Virgin soil: 500g/m2 Fertile soil: 300g/m2

Pre-winter and beginning of spring

Maintenance and feeding (repeat twice in period): 100g/m2

- 1. Be sure to water well, water has two functions in the process: it translocates the product to the roots and oxygen in water activates the nutrients of the product.
- 2. Avoid direct contact with leaves and roots.
- 3. Store in a cool dry place.
- 4. 1kg cover approximately 10m2
